NOTICE OF REPRESENTATION HEARING

LIUNA Local 1029 is seeking to establish a bargaining unit and to be certified as the exclusive representative of that unit for purposes of collective bargaining. The proposed bargaining unit includes: **ALL REGULAR FULL AND PART-TIME PSYCHIATRIC SOCIAL WORKERS I, II, III; FAMILY SERVICE SPECIALISTS; FAMILY SERVICE ASSISTANTS I, II; ADOLESCENT TREATMENT SERVICES COORDINATOR; AND ADMINISTRATIVE SPECIALIST, ADMINISTRATIVE SPECIALISTS I, II, III** (*excluding Treatment Team Leaders and all other supervisory employees as defined in 19 Del.C. Chapter 13*)

The State objected to the petition, asserting the petitioned for PSYCHIATRIC SOCIAL WORKER II AND III positions are supervisory and therefore ineligible for representation.

A public hearing will be conducted by the Public Employment Relations Board for the purpose of receiving evidence on the following issue:

WHETHER THE BARGAINING UNIT OF PSYCHIATRIC SOCIAL WORKERS II AND III EMPLOYED BY DSCYF/DPBHS CHILD & FAMILY CARE COORDINATION UNIT ARE SUPERVISORY EMPLOYEES PURSUANT TO 19 DEL.C. §1302 (s) which states:

“ ‘Supervisory employee’ means any employee of a public employer who has the authority, in the interest of the public employer, to hire, transfer, suspend, layoff, recall, promote, discharge, assign, reward or discipline other employees, or responsibility to direct them, or to adjust their grievances, or effectively to recommend such actions, if the exercise of such authority is not a merely routine or clerical nature, but requires the use of independent judgment.”
