POLLING TO BE CONDUCTED BY ELECTRONIC BALLOT

PURPOSE OF ELECTION

AN ELECTION BY SECRET BALLOT WILL BE CONDUCTED, under the supervision of the Public Employment Relations Board, among all regular full-time and regular part-time **NON-SUPERVISORY EMPLOYEES OF DSCYF/DPBHS/CONTINUOUS QUALITY IMPROVEMENT AND CONSULTATION UNIT**, to determine whether those employees desire to be represented by LiUNA Local 1029 for purposes of collective bargaining, as part of the existing bargaining unit of DSCYF/DPBHS, CAS and Intake employees, as defined in DOL Case 314.

ELIGIBLE VOTERS

**All Regular Full-Time and Regular Part-Time
NON-SUPERVISORY EMPLOYEES
of DSCYF/DPBHS/Continuous Quality Improvement and Consultation Unit
(CQIC)**

Employees defined as ELIGIBLE VOTERS who did not work during the payroll period because they were ill or on vacation or temporarily laid off and employees in the military service of the United States are eligible to vote.

Secret Ballot Election Procedures

This election will be by SECRET ballot cast electronically through the State of Delaware email system. Each eligible voter will receive an email directly from the Public Employment Relations Board which includes a sample ballot.

- The email will include a “voting button” with the option for the eligible voters, as a group, to either choose to be represented by LiUNA Local 1029, as part of the existing bargaining unit of DSCYF/DPBHS, CAS and Intake employees (YES) or for the group to remain unrepresented (NO).
- Voters will cast their votes by clicking the voting button icon in the “Respond” options, clicking their choice, and then sending the responsive email back to PERB. Instructions will be provided in the email to all voters.

Authorized Observers

LiUNA Local 1029 and DSCYF may each designate one observer and one alternate to observe the counting of the ballots on Thursday, August 20, 2026, at 1:00 PM. The observers should be persons familiar with the eligible voters.

INFORMATION CONCERNING THE ELECTION

THE RESULTS OF THIS ELECTION WILL BE DETERMINED BY THE MAJORITY OF THE VOTES CAST.

The ballots will be counted on **Thursday, August 20, 2026, at 1:00 PM.** The Public Employment Relations Act provides that only one valid representation election may be held in a twelve (12) month period.

Ballots will be counted at 1:00 p.m. on August 20

The election will be determined by the majority of the votes cast.
